- Passed MBBS/BDS Final Professional Examination.
- Has a provisional PM&DC license for House Job. (without the Provisional License the candidate will not be allowed to join the house job as per Pakistan Registration of Medical and Dental Practitioners Regulations, 2023)

**IMPORTANT INSTRUCTIONS ABOUT SELECTION:**

1. Merit will be based on cumulative Professional Marks as per PM&DC regulations.
2. To redress the Grievance of the graduates, the standing Grievance Committee will hear the applicants in person if someone has Grievance on merit & Committee will resolve their grievances purely on merit and as per policy within stipulated time.
3. One year House Job shall be based on four modules of 3-months duration each (as per Pakistan Registration of Medical and Dental Practitioners Regulations, 2023).
4. The Notified schedule will be put on notice Board of M.S office concerned notice Board.
5. The notified seat distribution plan can be changed by the Hospital administration as per Requirement of the institution.
6. Selection of a module and sequence of four modules will be according to the preference of the candidates as per their merit only.
7. A Vacant post of any unit as per notified plan cannot be transferred to any others unit for adjustments.
8. Horizontal or vertical movement of selected House Officers in modules, once notified shall not be allowed in order later to ensure merit and transparency.
9. The new house job session will start on 01-11-2024 if any house officer fails to join till 05-11-2024 he / she will be offered slot in the next rotation i.e. after three months and not in between.


