ADMISSION REGULATIONS 2024-2025

Shahida Islam Medical College & Shahida Islam Dental College Lodhran

All admissions to the MBBS and BDS programs will be carried out as per the following criteria and all the prevailing rulesand regulations of the regulator in this regard will be considered as part of these criteria.

APPLICANT ELIGIBILITY:

Students of any age and sex from all provinces of Pakistan, Islamabad, FATA, and foreign/dual national/overseas can apply for admission.

1) FOR THE LOCAL SEAT:

- a) The candidate who is a Pakistani national and has completed FSc /HSSC or equivalent in Pakistan. All other candidates who do not fall under this definition shall be treated as foreign student (having foreign nationality) for the purpose of admission.
- b) The candidate must have passed MDCAT Examination for the year 2023 or 2024 as per regulator notification.
- c) The candidate/ applicant must have obtained a Higher Secondary School Certificate qualification (HSSC) or an equivalent 12th grade qualification recognized in Pakistan and obtained a minimum of sixty percent (60%) marks therein, or a higher percentage as may be notified by the regulator **OR**
- d) The candidate/ applicant must have passed the mandatory subjects of biology and chemistry and either physics or mathematics in the examination of the Higher Secondary School Certificate or an equivalent 12th grade qualification recognized in Pakistan.

2) FOR FOREIGN QUOTA SEAT:

- a) The candidate who is not a Pakistani Student and holds a permanent foreign nationality or is on overseas (being a Pakistani citizen permanently resident in a foreign country) Pakistani, and who has studied and passed HSSC 12th grade examination or equivalent from outside Pakistan and is a resident of a foreign country at the time of applying for admission and possess a certificate from the institution last attended to this effect.
- b) There will be 15% quota for foreign candidates in MBBS and BDS separately.
- c) The candidate/ applicant must have obtained a Higher Secondary School Certificate qualification (HSSC) or an equivalent 12th grade qualification recognized in Pakistan and obtained a minimum of sixty percent (60%) marks therein, or a higher percentage as may be notified by the regulator **OR**
- d) The candidate/ applicant must have passed the subjects of biology and chemistry and either physics or mathematics in the examination of the Higher Secondary School Certificate or an equivalent 12th grade qualification recognized in Pakistan.
- e) The candidate must have **EITHER** passed MDCAT Examination for the year 2023 **OR** shall qualify SAT-II with minimum score of 550 in each subject **OR** a foreign MCAT examination **OR** UCAT examination with 50% marks in biology, chemistry, and physics/mathematics.

SCHEDULING OF ADMISSION PROCESS:

- 1. Admissions to Shahida Islam Medical College Lodhran shall be conducted through online application portal of the UHS Lahore.
- 2. The last date for online admission form deposition for MBBS will be as per the deadlines of UHS.
- 3. The students must choose the program in which they want to apply. A student having not applied to a given program shall not

be entitled to admission to such program.

- 4. Rs. 2000/- per program will be charged by UHS for processing application.
- 5. The students must choose the program in which they want to apply. A student having not applied to a given program shall not be entitled to admission to such program
- 6. The provisional merit list of selected students on local and foreign seats, will be notified after 3 days of closing date of application and final college wise merit list will be displayed on UHS website www.uhs.edu.pk
- 7. For a valid admission offer the student will be required to visit the college with all the original documents.
- 8. The final merit list shall represent an offer by the college to the students based on their merit against the allocated seat of each college.
- 9. The students selected will have three (3) working days to submit their fee which shall represent acceptance of offer by student. Evidence of fee payment / fee receipt must be emailed to admissions@simc.edu.pk for inclusion in final admitted list.
- 10. Any student not accepting the offer shall enable the next student in the merit list to avail themselves of the offer.
- 11. If a student after having obtained admission seeks to leave the program will have the deductions as per PM&DC and UHS prevailing regulations.
- 12. A student admitted to a foreign seat shall pay the fee as a foreign student regardless of any change in status of such student during the program of study.
- 13. A student who defaults on payment of tuition fee shall be liable to be expelled subject to a reasonable period (15 days) being granted to the student to remedy the defaulted fee. The information of the expelled student on account of default in payment of tuition fee shall be notified to the Regulatory Authorities within one week and the student registration with the Regulatory Authorities shall be cancelled permanently.
- 14. The admitted students Matric and Intermediate (or equivalent) certificates or credentials should be IBCC Verified after receiving the IBCC verification. The FINAL LIST of admitted students along with verifications will be forwarded to UHS and PM&DC for registration of the students with both authorities.
- 15. Any students whose certificates/credentials are not duly verified or are found to be false or forged shall have the admission terminated with immediate effect and his/her details will be communicated to UHS and PM&DC for further necessary action. The college will give the next student on the waiting list the admission/fee submission offer against that vacant seat.
- 16. A student when accepting admission to the college shall mandatorily disclose to the college if a prior admission has been accepted by the student to any other college, and such student shall prior to accepting such admission letter must in writing inform the prior college of cancellation of their acceptance with a copy to the designated email of the Authority. Failure by a student to cancel the prior acceptance of admission shall render all admission offers of the student as void and the student shall be ineligible for admission.
