Application of fresh graduates of (MBBS/BDS) of other colleges (Public/Private Sector of Pakistan and Foreign) Annual Session 2024 are invited through online portal at www.simc.edu.pk for House Job at Shahida Islam Teaching Hospital, Lodhran.

## **ELIGIBILITY FOR HOUSE JOB:** -

- Passed MBBS/BDS Final Professional Examination.
- Has a provisional PM&DC license for House Job. (without the Provisional License the candidate will not be allowed to join the house job as per Pakistan Registration of Medical and Dental Practitioners Regulations, 2023)
- Foreign graduates (MBBS/BDS) applying for house jobs must pass an OSPE-based exam covering core subjects— Medicine, Surgery, Gynecology, Eye, ENT for MBBS, and Periodontology, Oral Medicine, Operative Dentistry, Oral Surgery, Prosthodontics, Orthodontics for BDS—to assess clinical competency before eligibility.

#### **IMPORTANT INSTRUCTIONS ABOUT SELECTION:**

- 1. Merit will be based on cumulative Professional Marks as per PM&DC regulations.
- 2. To address the grievances of the graduates, the Standing Grievance Committee shall hear applicants in person, where applicable. The Committee shall resolve all grievances strictly on merit and in accordance with the approved policy, within the stipulated timeframe
- **3.** The one-year house job shall consist of four modules, each of three months duration, in accordance with the Pakistan Registration of Medical and Dental Practitioners Regulations, 2023
- 4. The Merit List and Selection List will be put on notice Board of M.S. office and no individual letter will be issued.
- 5. The notified seat distribution plan can be changed by the Hospital administration as per Requirement of the institution.
- 6. The selection and sequence of the four modules shall be determined based on the candidates' preferences, strictly in order of merit
- 7. A Vacant post of any unit as per notified plan cannot be transferred to any others unit for adjustments.
- 8. Horizontal or vertical movement of selected House Officers in modules, once notified, shall not be allowedin order later to ensure merit and transparency.
- **9.** The joining of house job will be on 30-06-2025.
