



Physical Therapy is an emerging profession in health care which promotes independent function and enhances the quality of life in individuals suffering with musculoskeletal or neurological impairments.





## HISTORY OF THE CITY OF LODHRAN

Lodhran District was an agricultural region with forests during the Indus Valley Civilization. The Lodhran area was ruled by the Maurya Empire, Indo-Greek Kingdom, Kushan Empire, Gupta Empire, White Huns, Kushano-Hephthalites, and Shahi Kingdoms. Later, it was ruled by Sultan Ghaznavi and then Mughal Empire. After the decline of the Mughal Empire, the Sikh Empire invaded and occupied Lodhran District. Raja Lodhra was the son of Sikh Raja Raam Dyo Minhas, and his family lived in Bahawalpur. Malik Ghulam Hussain Lodhra 'zaildar' suggested the name "Lodhran" for this area.

The English rulers first developed Lodhran city in the 18th century on the north side of the Sutlej River. The foundation of Lodhran was laid in 1830. During the period of British rule, Lodhran district increased in population and importance. In 1849, Multan District joined Lodhran, making it a tehsil on 5 May 1883. In 1991 after a movement of "Make Lodhran District" lead by M. Arshad Khan and Ch. M. Ali lasting for ten years convinced the government to declare Lodhran as a district. The announcement was made by the then Chief Minister, Mr. Ghulam Haider Wyne. Kehror Pakka and Duniyapur were made tehsils of District Lodhran.

After becoming the district still, the area is not developed, and the health care facilities are primitive. The only hospital is the DHQ hospital, which lacks specialized care, and patients needing specialist care must be referred to Bahawalpur or Multan.



## HISTORY OF SHAHIDA ISLAM MEDICAL COMPLEX LODHRAN

The chairman and the board of governors decided to build a state-of-the-art hospital and affiliated medical college in this underdeveloped area to benefit the community's poor people. The project started in 2013, and Shahida Islam Medical Complex was able to admit its first batch M.B.B.S. program in Shahida Islam Medical College (SDMC) during the 2016-17 session, along with the inauguration of Shahida Islam Teaching Hospital in 2016. The complex arranged free medical camps and started free beds and OPD service, continuing till now.

There is no turning back since then. Within a short span of three years, with a strong emphasis on balanced progress and focus on human capital, the institution has grown to Shahida Islam College of Rehabilitation Sciences (SICRS) in 2018, Shahida Islam Nursing College (SINC) in 2018, Shahida Islam Dental College (SDDC) in 2019 and Shahida Islam Paramedical School (SIPS) in 2019. While in 2020 when the whole world was at stand still, we came up with an idea to establish a pharmacy institute as it is an integral part of the medical & allied sciences now a days and by the grace of Allah, we have got the Shahida Islam College of Pharmacy (SICP) established & recognized with admissions started for 2020-21 session. The institution has strived from the beginning to attain excellence in teaching and health care delivery and has earned a good reputation nationally and internationally.

Shahida Islam Medical Complex was established with a unique focus on professional and technical education as they act as a powerful instrument in the growth and development of any country. It has state of the art well-equipped labs in medicine, dentistry, physiotherapy, nursing, pharmacy, and paramedical departments. To promote the learning of its students, it has established excellent links with national institutions and universities.

The institution also has a strong focus on postgraduate training. Postgraduate teaching in six disciplines started in 2019, and many departments have been recognized later and many are in the pipeline for recognition of the postgraduate training.

The institution is eying to develop its university in the future.



## Eligibility Criteria, Rules, and Regulations

### Admission Procedure

All admissions to the M.B.B.S. program will be carried out in line with the prevailing rules and regulations of the regulator. Students from all provinces of Pakistan, Islamabad, FATA & overseas can apply for admission.

- Admissions to Shahida Islam Medical College Lodhran shall be conducted through online application portal of the college.
- The online acceptance of MBBS registration applications will be available at [www.simc.edu.pk](http://www.simc.edu.pk) after the announcement of MDCAT result..
- The students must choose the program in which they want to apply. A student having not applied to a given program shall not be entitled to admission to such program.
- The foreign student is the one who has foreign nationality or is an overseas (being a Pakistani citizen permanently resident in a foreign country) There will be 15% quota for Foreign Students.
- Rs. 2000/- per programme will be charged for processing of application. The student must deposit the fee in **Bank Alfalah** IBAN Account No.**PK36ALFH0085001005329999** (account title Shahida Islam Medical Complex Pvt Ltd) and attach the scan of original deposit slip with the online form.
- The last date for online admission form deposition for **MBBS** will be **20<sup>TH</sup> December 2023**.
- Provisional merit list will be displayed within 3 days after the closure of applications and final merit list will be displayed by or before 15<sup>th</sup> January 2024 on college website [www.simc.edu.pk](http://www.simc.edu.pk)
- The final merit list shall represent an offer by the college to the students based on their merit against the allocated seat of each college.
- The students selected will have three (3) working days to submit their fee which shall represent acceptance of offer by student. Evidence of fee payment / fee receipt must be emailed to [admissions@simc.edu.pk](mailto:admissions@simc.edu.pk) for inclusion in final admitted list.
- Any student not accepting the offer shall enable the next student in the merit list to avail of the offer.
- If a student after having obtained admission seeks to leave the program will have following deductions.
  - Within 15 days of admission / before 30<sup>th</sup> January 2024 → one-time admission fee.
  - After 15 days of admission/ after 30<sup>th</sup> January 2024 → admission fee plus the tuition fee pro rata to the period spent by the student in the program along with a penalty of ten percent of the total annual fee.
- The admitted students Matric and Intermediate (or equivalent) certificates will be sent to respective boards for verification. Any students whose certificates/credentials are not duly verified or are found to be false or forged shall have the admission terminated with immediate effect with intimation to UHS and regulatory authority. The college will give the next student in waiting list the admission/fee submission offer against that vacant seat.
- After verification, the FINAL LIST of admitted students along with verifications will be forwarded to UHS and regulatory authority for registration of the students with both authorities.
- A student when accepting admission to the college shall mandatorily disclose to the college if a prior admission has been accepted by the student to any other college, and such student shall prior to accepting such admission letter must in writing inform the prior college of cancellation of their acceptance with a copy to the designated email of the Authority. Failure by a student to cancel the prior acceptance of admission shall render all admission offers of the student as void and the student shall be ineligible for admission.

**IMPORTANT NOTE:** These rules, regulations and timelines can be modified according to the any new Federal/Provincial Government Policies and/or any new regulatory authority notifications. Candidates must get updated information from college website [www.simc.edu.pk](http://www.simc.edu.pk) or college admission office at time of applying for the above programs.

## Eligibility Criteria, Rules, and Regulations

### Fee Payment

1. The discounted tuition fee (fixed annual charges), hostel fee (for boarders) and transport fee (for day scholars) will be charged on an annual basis and will have to be paid in advance before the start of the academic session.
2. Hostel, Mess, and transport charges can be changed at any time during the academic year and will have to be paid in advance.
3. The schedule of next year's fee submission will be notified during August each year.
4. Admission fee and hostel fee, once paid, are non-refundable.
5. The tuition fee and other charges once paid are only refundable as per the PM&DC policy.
6. As per PM&DC admission regulations, discounted fee for the students opting annual fee submission is displayed on the college website. The students opting for fee submission six monthly will have to pay 2% extra on the tuition fee while student opting for fee submission on quarterly basis will have to pay 4% extra on the tuition fee.
7. Applicants should seek clarification about fees/ other dues from the Accounts Office or [admissions@simc.edu.pk](mailto:admissions@simc.edu.pk) before depositing as otherwise the institution will be bound to follow clause 4, 5 & 6 of fee structure.
8. Students defaulting in fee payment may be expelled/suspended and/or barred from attending the classes and examination until the clearance of dues in accordance with the college policies and procedures. In addition, late fee submission charges as per college policy will be collected.
9. There is no extra tuition fee for the supplementary examination.
10. The students repeating the year based on being debarred from appearing in the university examination shall be charged the full fee as per the session with which he/she will be studying for next year.
11. The detained students will be charged a fee in proportion to the number of failed subjects of that professional examination as per the session with which he/she will be studying for next year.
12. Students will not be allowed to appear in any university examination unless all outstanding dues are fully cleared before the examination's registration deadline.
13. Any further additional charges levied by the government, the

University of Health Sciences or the PM&DC during studies will be charged from the students.

IMPORTANT NOTE: These rules and regulations can be modified according to the PM&DC notifications.

### Financial Incentive/ Academic Scholarship

1. The students securing 1st, 2nd, or 3rd positions in the annual university examination will be given a 100% fee waiver for the next academic year with Rs: 50,000 cash awards.
2. The top 5 students securing more than 85% marks (theory portion) in the annual university examination will be given the academic scholarship equivalent to 20% of the yearly tuition fee in the coming year.

### Migration Policy

1. Migration rules of the PM&DC and the UHS will be followed.
2. Student seeking migration will be issued NOC by the college depending on the availability of seat in that session.
3. A student must get the NOC from the UHS, after that his/her student registration will be sent.
4. Once registered with the UHS then he/she will be allowed to attend the classes and information will be sent to the PM&DC for updating the record.

### Criteria to sit in Professional Examination

1. Clearance of all types of college dues.
2. 85% attendance in lectures, demonstrations, practical and clinical rotations in each subject.
3. 50% marks in send-up examination per subject/ 50% cumulative marks in block exams.

IMPORTANT NOTE: Any student not fulfilling any one of the above criteria becomes ineligible to sit the professional examination and this decision is not challenge-able in any court of law. The criteria can be modified according to any new PM&DC/UHS regulations made at any time during the session.

### Pass Marks

1. Pass marks for professional examinations are 50% independently in theory and practical examination.
2. If a candidate fails any part of the exam, i.e., theory or practical/clinical, he/she must reappear in both.



- Admissions to Shahida Islam Dental College Lodhran shall be conducted through online application portal of the college.
- The online acceptance of BDS registration applications will be available at [www.simc.edu.pk](http://www.simc.edu.pk) after the announcement of MDCAT result.
- The students must choose the program in which they want to apply. A student having not applied to a given program shall not be entitled to admission to such program.
- The foreign student is the one who has foreign nationality or is an overseas (being a Pakistani citizen permanently resident in a foreign country) There will be 15% quota for Foreign Students.
- Rs. 2000/- per programme will be charged for processing of application. The student must deposit the fee in **Bank Alfalah** IBAN Account No.**PK36ALFH0085001005329999** (account title Shahida Islam Medical Complex Pvt Ltd) and attach the scan of original deposit slip with the online form.
- The last date for online admission form deposition for **BDS** will be **20<sup>TH</sup> December 2023**.
- Provisional merit list will be displayed within 3 days after the closure of applications and final merit list will be displayed by or before 15<sup>th</sup> January 2024 on college website [www.simc.edu.pk](http://www.simc.edu.pk)
- The final merit list shall represent an offer by the college to the students based on their merit against the allocated seat of each college.
- The students selected will have three (3) working days to submit their fee which shall represent acceptance of offer by student. Evidence of fee payment / fee receipt must be emailed to [admissions@simc.edu.pk](mailto:admissions@simc.edu.pk) for inclusion in final admitted list.
- Any student not accepting the offer shall enable the next student in the merit list to avail of the offer.
- If a student after having obtained admission seeks to leave the program will have following deductions.
  - Within 15 days of admission / before 30<sup>th</sup> January 2024 → one-time admission fee.
  - After 15 days of admission/ after 30<sup>th</sup> January 2024 → admission fee plus the tuition fee pro rata to the period spent by the student in the program along with a penalty of ten percent of the total annual fee.
- The admitted students Matric and Intermediate (or equivalent) certificates will be sent to respective boards for verification. Any students whose certificates/credentials are not duly verified or are found to be false or forged shall have the admission terminated with immediate effect with intimation to UHS and regulatory authority. The college will give the next student in waiting list the admission/fee submission offer against that vacant seat.
- After verification, the FINAL LIST of admitted students along with verifications will be forwarded to UHS and regulatory authority for registration of the students with both authorities.
- A student when accepting admission to the college shall mandatorily disclose to the college if a prior admission has been accepted by the student to any other college, and such student shall prior to accepting such admission letter must in writing inform the prior college of cancellation of their acceptance with a copy to the designated email of the Authority. Failure by a student to cancel the prior acceptance of admission shall render all admission offers of the student as void and the student shall be ineligible for admission.

## Eligibility Criteria, Rules, and Regulations

### Fee Payment

1. The discounted tuition fee (fixed annual charges), hostel fee (for boarders) and transport fee (for day scholars) will be charged on an annual basis and will have to be paid in advance before the start of the academic session.
2. Hostel, Mess, and transport charges can be changed at any time during the academic year and will have to be paid in advance.
3. The schedule of next year's fee submission will be notified during August each year.
4. Admission fee and hostel fee, once paid, are non-refundable.
5. The tuition fee and other charges once paid are only refundable as per the PM&DC policy.
6. As per PM&DC admission regulations discounted fee for the students opting annual fee submission is displayed on the college website. The students opting for fee submission six monthly will have to pay 2% extra on the tuition fee while student opting for fee submission on quarterly basis will have to pay 4% extra on the tuition fee.
7. Applicants should seek clarification about fees/ other dues from the Accounts Office or [admissions@simc.edu.pk](mailto:admissions@simc.edu.pk) before depositing as otherwise the institution will be bound to follow clause 4, 5 & 6 of fee structure.
8. Students defaulting in fee payment may be expelled/suspended and/or barred from attending the classes and examination until the clearance of dues in accordance with the college policies and procedures. In addition, late fee submission charges as per college policy will be collected.
9. There is no extra tuition fee for the supplementary examination.
10. The students repeating the year based on being debarred from appearing in the university examination shall be charged the full fee as per the session with which he/she will be studying for next year.
11. The detained students will be charged a fee in proportion to the number of failed subjects of that professional examination as per the session with which he/she will be studying for next year.
12. Students will not be allowed to appear in any university examination unless all outstanding dues are fully cleared before the examination's registration deadline.
13. Any further additional charges levied by the government, the University of Health Sciences or the PM&DC during studies will be charged from the students.

IMPORTANT NOTE: These rules and regulations can be modified according to the PM&DC notifications.

### Financial Incentive/ Academic Scholarship

1. The students securing 1st, 2nd, or 3rd positions in the annual university examination will be given a 100% fee waiver for the next academic year with Rs: 50,000 cash awards.
2. The top 5 students securing more than 85% marks (theory portion) in the annual university examination will be given the academic scholarship equivalent to 20% of the yearly tuition fee in the coming year.

### Migration Policy

1. Migration rules of the PM&DC and the UHS will be followed.
2. Student seeking migration will be issued NOC by the college depending on the availability of seat in that session.
3. A student must get the NOC from the UHS, after that his/her student registration will be sent.
4. Once registered with the UHS then he/she will be allowed to attend the classes and information will be sent to the PM&DC for updating the record.

### Criteria to sit in Professional Examination

1. Clearance of all types of college dues.
2. 85% attendance in lectures, demonstrations, practical and clinical rotations in each subject.
3. 50% marks in send-up examination per subject/ 50% cumulative marks in block exams.

IMPORTANT NOTE: Any student not fulfilling any one of the above criteria becomes ineligible to sit the professional examination and this decision is not challenge-able in any court of law. The criteria can be modified according to any new PM&DC/UHS regulations made at any time during the session.

### Pass Marks

1. Pass marks for professional examinations are 50% independently in theory and practical examination.
2. If a candidate fails any part of the exam, i.e., theory or practical/clinical, he/she must reappear in both.





# Shahida Islam Medical Complex General Rules and Regulations

## COLLEGE CODE OF CONDUCT

The following general disciplinary rules must be followed by all the students. A violation of these regulations is an offense against the Institution.

However, such violations are not here considered as crimes – unless convicted and penalized by any court of law outside the college premises.

### 1. Uniform

- a. The students must wear the prescribed uniform of their institution daily during college time.
  - i. The students must display their COLLEGE STUDENT CARD prominently on their uniform all the time.
  - ii. The students must wear WHITE COAT while attending laboratories, dissection hall and hospital.
  - iii. The female students wearing ABAYA are permitted to wear only the color of respective institution uniform i.e., MAROON for SDMC, CAMEL for SDDC, OLIVE GREEN for SSCP, NAVY BLUE for SICRS, GREY for SINC and SKY BLUE for SIPS. No other colors of abaya are allowed.
  - iv. The VEIL should be either of the same college color or Black. No other colors of veils are allowed.
  - v. The SCRUB SUIT is only allowed to the students attending operation theater.
  - vi. The scrub suit should have a college monogram and student name engraved.
  - vii. The students of 4th year MBBS are only allowed to go to Eye and ENT operation theaters and students of Final Year MBBS are only allowed to go to Surgery and Gynecology operation theaters. No student of any other class or any other department is permitted to enter the OT.
  - viii. The students must wear CLOSED SHOES. Any kind of sandals, chappals and open shoes are not allowed with uniform or with scrub suits.
  - ix. Any deviation from these uniform regulations will be liable to disciplinary action and fine.

### 2. Attendance

- a. Every student shall be required to attend at least 85 per cent of the lectures, seminars, tutorials, practical and clinical classes of each subject in each class failing which he/she shall not be eligible to appear in the examination concerned.
- b. The margin of fifteen per cent of absences is intended to cover absence only on account of sickness or a special emergency considered justifiable by the head of the institution.
- c. A written application should be sent to the head of the institution by the student or his/her parent or guardian, reporting his/her illness or cause of absence.
- d. Every student is required to attend punctually the hours notified for lectures, demonstrations, seminars, tutorial classes, practical and hospital wards.
- e. Students availing leave or being absent for >18 days from college or hospital work shall be liable to attend remedial classes to become eligible for the professional exams.
- f. Students must be present in time at any specified activity of the institution.

### 3. Classroom

- a. Students are expected to extend the highest level of courtesy and respect towards their teachers.
- b. No student is allowed to leave the lecture room without the permission of his teacher or until the class is dismissed.
- c. The attendance will be marked through Biometric Machines 10 minutes after the start of lecture. A student coming late into the classroom will be marked absent unless his excuse is accepted by the teacher.
- d. Any student misbehaving in the classroom shall at once be reported by the teacher to the Head of the Institution for necessary action.
- e. Students are not permitted to remain in the lecture room except during the prescribed hours of lectures.

## 4. Hospital

- a. Students attending hospital teaching are required to abide by the hospital rules and while in the hospital they are under the supervision of Medical Superintendent for disciplinary purpose, who may impose any of the following punishments on any student committing any offence in the hospital or for neglect or not properly carrying out any duty entrusted to him/her in the hospital.
  - i. Debar him/her from attending any or all the departments or hospital for a period not exceeding three months. OR
  - ii. Impose such a fine not exceeding Rs2000/- as he may consider appropriate.
- b. Applications for leave from students doing duty in the hospital wards or outpatients departments must be submitted through their respective clinical head to the Head of the Institution.
- c. Every student is required to attend punctually at the hours notified for clinical teaching and ward duty.

## 5. Class Examination

- a. Students are not allowed to take into the examination hall textbooks, notes, or manuscript of any kind
- b. Any student found infringing the examination rules or having recourse to unfair means may be expelled from the examination and the matter shall be reported to the head of the institution who may refer his case for action to the disciplinary committee of the Institution.
- c. Late comers arriving at the examination hall more than 15 minutes after the start of the paper will not be allowed to enter the examination hall.

## 6. Leave

- a. Sick leave will only be granted on the production of a medical certificate

- b. In all cases leave taken will be at the student's own risk so far as the percentage of attendance is concerned and even the medical certificate will not condone a deficiency in attendance.
- c. Students must not leave the station without the permission of the head of the institution
- d. A student who is absent without leave continuously for a period of four weeks will be struck off from the college roll.

## 7. Students Medical Certificate and Treatment

- a. Non boarders / boarders already on vacation/ leave must obtain a medical certificate from a Professor /Associate Professor of any Medical College.
- b. For boarders, including those on duty in the hospital the medical certificate must be signed by a Professor /Associate Professor of the institution.
- c. A medical certificate must specify the nature of the illness and the period with dates of leave recommended on account of that illness
- d. Students who fall ill will be provided treatment on an outpatient basis.
- e. Students requiring hospitalization will be entitled to the facilities of the general ward patients

## 8. Books

- a. Every student shall provide himself with all the prescribed textbooks and other necessary instruments etc.

## 9. Correspondence

- a. Students are forbidden to address any member of the Board of Directors directly. Any communication intended for such higher authority must be submitted through the head of the institution who will forward it if he considers it desirable.

- b. Students desirous of addressing the head of the institution by a letter must do so independently. Joint applications are entirely prohibited and will not receive attention.
- c. Any student wishing to make a representation on any subject has the right to direct access to the head of the institution at any time during the college hours.
- d. Head of the institution, Professors and other staff are accessible at any time for listening to the difficulties and grievances of students and shall always be pleased to advise them.
- e. Any student breaking or damaging any property of the institution shall be required to pay the cost of repair or replacement.
- f. In case of willful damage, he/she shall be punished under the disciplinary rules of the institution.
- g. If a student of the institution takes part in any political activity or conducts himself/herself in an unbecoming manner or in such manner as would interfere with the corporate life or educational work of the institution, the head of institution may take any action he deems proper or bring the matter before the College Academic Council for proper action.
- h. No person shall be invited to address a meeting or society in the institution premises without prior permission of the head of the institution. In all cases, the chair shall be occupied by a responsible person approved for the purpose by the head of the institution. The subject of debate shall be fixed after obtaining the approval of the head of the institution in advance.
- i. No student shall address a Press Conference, nor write to the press on the political or related subject or matters concerned directly with the administration of the institution, University or any Government or Educational Institution in Pakistan or abroad. No poster or banner shall be put up without the approval of the head of the institution.
- j. No society may be set up by the students or any meeting held in the institution premises without the written permission of the head of the institution.
- k. Riots, strikes, boycotts and demonstrations which create disturbance for other students, or the public are not allowed.

## 10. General Rules

- a. Students are required to always observe order and discipline in the institution, attached hospitals and hostels.
- b. Smoking within the institution, attached hospitals and hostels premises is entirely prohibited.
- c. Students cannot keep firearms, non-firearm weapons (knuckles, swords, spear etc.) and non-firearm ranged weapons (bow & arrow, javelin, air gun etc.). Any breach of this will result in strict disciplinary action.
- d. No game of any sort is to be played during the classes and hospital duty hours.
- e. Displaying and distribution of partisan/ ethnic/ sectarian/ political pamphlets or circulars etc. in the institution, attached hospitals and hostels premises is not allowed.
- f. All irregularities, neglect of duties and breach of discipline are to be brought to the notice of the head of the institution by the Professor under whom the student is working.
- g. Every student to whom books or other property of Government is entrusted shall be held responsible for their preservation in good condition and in the event of their being lost or damaged shall be required to replace them or repay their cost.

- o. Aliens/Outsiders are not allowed right of entry / use of institutional facilities/ libraries/ reading rooms/ playgrounds/ any training facility or recreational facility or any facility which the institution owns directly or indirectly. Entry of an alien in the institutional facility amounts to trespassing. An alien found within any institutional facility(s) upon identification will be requested to leave the premises immediately; in case of non-compliance institution reserves the right to expel the offending alien and / or report the case to police for unauthorized forced entry as a criminal act.
- p. Bringing or facilitation of an alien/outsider to the institutional facility without lawful authorization is a violation of regulations and is accordingly punishable.

## 11. Violations

- a. Level 1 Violation (Minor):
  - i. These may occur because of inexperience or lack of knowledge of Institutional Conduct and Discipline Regulations on the part of persons committing the violation.
  - ii. These violations address incidents when intent is questionable, are not extensive and are unplanned.
  - iii. In the context of academic setting occur on a minor assignment or minor infringement of examination regulations.
  - iv. These are generally handled at the local level but may be referred to Disciplinary Committee (DC) at the discretion of HOD.
- b. Level 2 Violation (Intermediate):
  - i. These are characterized by dishonesty, unwholesome behavior or delinquency of a more serious character falling between level 1 and level 3 violations or which interrupts institute functions in non-significant manner.
  - ii. In academic setting it reflects moderate degree of cheating / plagiarism / infringement / delinquency to affect a more significant aspect or portion of the course work or more than negligible examination misconduct.
- c. Level 3 Violation (Major):
  - i. These are those that go beyond Level One or Two violations. They are in violation of Conduct and Discipline Regulations on the campus to interfere with institutional function in a significant manner or duration or are preceded by one or more violations at Levels 1 and / or 2.
  - ii. In the context of academic setting, it means cheating / plagiarism / infringement / delinquency that affects a major or essential portion of work done to meet course requirements.
- d. Level 4 Violation (Serious):
  - i. These represent the serious breaches of institutional Rules / Regulations of Conduct and Discipline.
- e. Level 5 Violation (Most Serious):
  - i. These violations represent the most serious disobedience or violence or deliberately breaking the Conduct and Discipline Regulations.
- f. These Conduct and Discipline Regulations may not cover all the possible eventualities and Principal will be authorized to refer any issue / person in the context of conduct and discipline of the students /employee to Disciplinary Committee or to any authority of the institution or that of State of Pakistan or any other regulatory authority outside the college.
- g. The college will make these rules and regulations readily available to all the persons concerned.

# Shahida Islam Medical Complex General Rules and Regulations

## COLLEGE DISCIPLINARY AND GRIEVANCE POLICY

- 1) For all such offences that occur in the Institution, attached hospitals and hostels premises, head of the institution may at his discretion refer the case to the Disciplinary Committee of the institution, which shall be appointed by the principal from time to time.
- 2) This Disciplinary Committee shall have the power to interview any student or students or any member of the staff or any member of public and is empowered to send its recommendations to the head of the institution who may or may not seek ratification of these recommendations by the Academic Council.
  - a) The Disciplinary Committee shall consist of:
    - i) Five Professors including its chairman to be nominated by the principal; and
    - ii) The teacher or officer in-charge of academic /student affairs by whatever name called shall be its Secretary.
    - iii) The term of office of the members of the Discipline Committee, other than ex-officio members, shall be two years.
    - iv) The quorum for a meeting of the Discipline Committee shall be three members including its chairman.
    - v) The functions of the Disciplinary Committee shall be to
      - (1) Deal with complaints from college officials, any other complainant or on a suo-moto action by the Principal / Directors.
      - (2) Deal with all inter-institute cases of indiscipline in the college.
      - (3) Recommend to the Principal, the fine, warning, suspension, expulsion or rustication of the faculty member, student, staff, or visitor based on inquiry conducted under the rules and regulations.
      - (4) Perform such other functions as may be prescribed.
  - 3) The Procedure of Complaint:
    - a) Any complaint against the faculty member, student, staff, and visitor, unless specified otherwise, shall be addressed to the Principal of the College.
    - b) In the event of Suo-moto's action the Vice Principal /Dean /Medical Superintendent will be the complainant.
    - c) The principal may take one of the following Actions
      - i) Finding the complaint frivolous, file it.
      - ii) May conduct a personal hearing to ascertain facts and subsequently may reject the complaint.
        - iii) If the Principal is certain that the complaint is genuine then refer the matter to the Disciplinary committee for further action.
    - d) The Disciplinary committee shall adopt the following procedure:
      - i) Review the evidence, statements and / or other material contained in the complaint and make a preliminary endeavor to ascertain facts.
      - ii) Frame the charges.
      - iii) Issue notices to all concerned.
      - iv) Interview of accused, complainant, witnesses, and others if any for statements, and recording of evidence.
      - v) No Lawyer shall be allowed on behalf of any Party.
      - vi) Collect evidence.
      - vii) Fix the responsibility.
      - viii) Recommend the penalties for all those found guilty according to the regulations.
      - ix) Compile the report under seal to the principal office.
    - e) The procedure of appeal will be as follows:
      - i) The accused, complainant or the victim can lodge an appeal against the interim order of the disciplinary committee, through the office of Principal within seven (07) working days from the date of receiving the order.
      - ii) The right to appeal is for one time only.
      - iii) If there is no appeal within this specified time the principal can himself issue the notification of penalty or in case of major penalty may send the case to Academic Council for approval and further action.
      - iv) In case of an appeal lodged against the decision of the disciplinary committee, this appeal will be sent for review to the Academic Council.
      - v) The Academic Council, in this context, will admit new evidence. It may or may not also solicit response / testimony / additional information from the charged person, the victim, the complainant, the DC members, and any relevant witnesses to reach a conclusion.
      - vi) Subsequently academic council by a majority vote may take one of the following Decisions.
        - (1) Reject the appeal and deny the request for reconsideration of Sanction(s)
        - (2) May increase the penalty - giving the reasons.
        - (3) May reduce or otherwise limit the penalty-assigning reasons.
        - (4) Direct the Disciplinary Committee to proceed afresh, if there is new information which was not available at the time of the hearing by the disciplinary committee.
        - (5) The Academic Council's decision will be referred to the Disciplinary Committee through the office of Principal.

- vii) The Disciplinary Committee will review the recommendations of Academic council to implement its decision and send the final recommendations to the principal within seven working days.
- viii) Before issuing his final orders, Principal may or may not call for repeat examination of accused, complainant, witnesses, and any other person to satisfy himself about lawful reasonability of punishment.
- ix) The principal may accept or modify the recommendations of Disciplinary Committee and issue the final order of punishment, giving reasons in writing about modifications if any in his orders.

## 4) Proposed Penalties against the students

- a) The Disciplinary Committee / Principal can take one or more of the following disciplinary actions against the students committing an offence depending upon the severity of the offence (Level-1 to Level-5 mentioned in code of conduct).
    - i) The student may be asked to tender an apology, verbal or written. This shall be placed on the student's record.
    - ii) The student may be placed on probation for a period up to one year. If during the period of probation, he /she fail to improve his/ her conduct, he/she may be expelled from the Institution.
    - iii) The student may be fined up to Rs. 5000/-
    - iv) The student Scholarship/Grant-in-aid may be suspended or stopped.
    - v) The student may be suspended from the institution roll for a period determined by the head of the institution.
    - vi) The student may be expelled from the institution for a period determined by the head of the institution.
    - vii) The student may be forcibly migrated to another medical/dental institution of the province.
  - b) The head of institution is competent to impose/remit fines and punishments.
  - c) The decision of the Head of Institution shall be considered as final.
- 5) The college will make these rules and regulations readily available to persons who may be affected by them, on demand.

## COLLEGE EXAMS POLICY

The following will be followed in true letter and spirit regarding student internal tests and examinations.

- 1) The Department of Medical Education (DME) will be responsible for making the examination calendar for every professional year in consultation with the concerned heads of departments for that year.
- 2) DME will notify the weekly test schedule, term test date sheet, and send up examination date sheet of all classes of every constituent institution.
- 3) All the departments must follow the notified schedule and no unscheduled written tests will be allowed.
- 4) Any department needing a change in schedule will inform the DME and the DME after due consideration will notify the change.
- 5) The topic of the test must be intimated to the students at least one week prior to the date of the test with a copy for information to the DME.
- 6) The concerned HODs will be responsible for setting of paper, printing and secrecy of paper and conduction of exam/test.
- 7) The DME will provide all the examination material like white papers for printing of question paper, answer sheets, stapler, extra sheets, and award lists etc. to the concerned department as per their requirement on indent.
- 8) The concerned department will return the unused material to DME on the same indent book so as the material can be used in other exams.
- 9) The concerned HODs will submit the result along with the answer books and the question paper to the DME within 10 working days after the exam/test.
- 10) The DME will notify the result and will do the item analysis of the paper and give feedback to the concerned department.
- 11) The viva/ practical examination of term or send up will also be conducted as per date sheet notified by the DME.

- 12) The materials required for viva/ practical examination will be provided by DME. The written request by the concerned HOD must reach the DME at least a week before the exam date to arrange the materials in time.
- 13) The results of viva/practical examination must reach the DME within 3 working days after completion of examination.
- 14) The passing marks criteria for students in weekly test, term, and sendup examinations are 50%.
- 15) The student being absent in weekly test, term, or sendup examination without leave OR the student who leaves the paper blank or write things which are unrelated, or offensive will be fined Rs. 5000/- and will have 15% deduction in marks in the next test of that subject.
- 16) Any student failing the weekly test, term, or sendup examination by scoring less than 30% marks will be fined Rs. 1000/- to 5000/- depending on previous performance in class and assessment by the concerned HOD.
- 17) The student who is absent in the classes on any day immediately prior to the test day will have 10% deduction in marks of that test e.g., if there is a test of subject 'A' on Thursday then students absent on Wednesday without prior permission will have 10% marks deduction straight away in the subject 'A' test on Thursday. In addition, a fine of absence may be imposed.
- 18) Students are not allowed to take into the examination hall mobiles, laptops, textbooks, notes, or manuscript of any kind.
- 19) Any student found infringing the examination rules or having recourse to unfair means may be expelled from the examination and the matter shall be reported to the head of the institution who may refer his case for action to the disciplinary committee of the Institution.
- 20) Late comers arrive at the examination hall more than 15 minutes after the start of the paper will not be allowed to enter the examination hall.

## LIBRARY RULES

The following shall be entitled to use the library.

- a) The faculty of the complex and allied hospital
  - b) Students of the complex
  - c) Other doctors as approved by the library committee.
- 1) Students after admission shall get library borrower card from the librarian. One book for 2 weeks can be issued on card, and this is non-renewable and non-transferable.
  - 2) The borrower card is not transferable, and loss of borrower cards should be reported to the librarian immediately. Issuance of duplicate borrower card will be made against the charges.
  - 3) Students can avail themselves of reference books/journals within the library premises, but these can't be issued on card.
  - 4) Books required for occasional reference like encyclopedia, dictionary etc. and books of great value will not be issued.
  - 5) The student must return the book within 14 days of issuance. For each additional day a fine of Rs.50/- per day will be charged (not exceeding the price of the book). Further issuance of the books will be stopped till the fine has been paid and the books returned.
  - 6) In case of a reason of non-return of book is beyond control of the student he/she can apply in writing for reduction of fine. The head of the institution, if satisfied with the reason, can reduce the fine.
  - 7) During stock taking all the books must be returned.
  - 8) Gossiping, mobile calls, sleeping, eating, drinking, smoking, chatting, combined study and disturbing the order of library furniture are strictly prohibited in the library.
  - 9) Damage done to library material (folding, writing, underlining, defacing, damage or tearing of pages etc.) will be liable to fine and the decision of the library committee will be final.
  - 10) Stealing /Loss of any library material would be charged at three times the current price or replacement of that material.
  - 11) Personal belongings (books, files, briefcases, handbags, register etc.) are not allowed inside the library.
  - 12) Library membership would be suspended or cancelled along with penalty in case of Nonpayment of library fine, Misconduct with library staff, Theft of library material, Misconduct /disturbance in library, non-returning of issued material and Breach of any library rules.

## COLLEGE HOSTEL RESIDENTS' POLICY

The following should be followed in true letter and spirit regarding hostel residing by the boarder Students.

### HOSTEL ADMINISTRATION/ MANAGEMENT

1. Hostel Management hierarchy will be Chief Warden Boys and Girls Hostel, Warden Boys Hostel, Warden Girls Hostel, Caretaker of Boys & Girls Hostel.
2. The Chief Warden and Warden must be from the teaching faculty preferably those residing inside the college premises.
3. The Caretaker can be any graduate male / female who must reside within the campus premises 24/7.
4. It would be the responsibility of the caretaker to make sure Security guards, Sweeper and Ayas are present in the hostel.
5. Caretaker will be responsible to communicate with the mess and cafeteria regarding the number of students present in the hostels and regarding the food problems.
6. In case the student wants to go outside the college premises the student will have to fill the gate pass and get it signed by the hostel warden one day before leaving the college/hostel premises.
7. To avail the college transport for going to the bus station/railway station/ airport the students will have to inform the warden one day before while signing the gate pass.
8. The hostel resident students will contact the caretaker for all their day-to-day activities and problems and in case the problem is not solved then they can contact the Warden directly. However, the hostel leaving permission will only be granted by the

Warden and not the caretaker.

9. The caretaker will submit any complaints received from the students and any complaints about the students etc. to the Warden immediately via phone or maximum within 24 hours depending upon the urgency of the issue.
10. The Warden will take the appropriate corrective action immediately.
11. The Warden can impose minor fine (Rs.1000-5000/-) to the students in case of MINOR MISCONDUCT with intimation to the Chief Warden and Principal.
12. In case of non-compliance of fine deposition by the student or an act of MAJOR MISCONDUCT the Warden Hostel can impose major fine (Rs.10000-50000/-) with or without expulsion from hostel after consultation with the Chief Warden and Principal.
13. The Chief Warden has the right to increase the fine or recommend expulsion from hostel depending on the scenario.
14. The decision of expulsion from hostel will be vetted by the College Academic Council and the decision of Academic Council will be final.

### GENERAL RULES

1. Accommodation in hostel cannot be claimed as a matter of right, the hostel administration can refuse accommodation to any student who is known to have violated hostel rules or whose presence is likely to disturb the peace and tranquility of hostel or whose presence can cause serious adjustment problems with the fellow students.
2. The residents of Bahawalpur and Lodhran City will not be preferably considered for hostel allotment except in special circumstances, in which case the permission must be formally acquired from the principal.
3. Room once allotted, and the roommate once.

- chosen/allotted will not be changed except by the permission of the Warden on provision of valid reasons and grounds. Violation of this rule will be considered as Major Misconduct.
- Every resident must strictly observe all the rules currently in force or as may be enforced from time to time by the administration.
  - Every resident must look up the student notice board regularly for any new orders etc. No excuse of not knowing the rules once displayed on notice board for 24 hours will be acceptable.
  - Upon room allotment the student will be given a bed, table chair and cupboard by the institution while the bedding and clothing etc. must be brought in by the student. The student must have to take care of the articles issued and the electricity appliances installed in the room (lights, fan, electricity panels and buttons etc.). Any breakage of these articles will be considered as Minor Misconduct and the student also must pay for the repair of the article damaged.
  - Every resident must maintain peace, tranquility, and calm atmosphere in the hostel with respect to right of the others. The violation of this rule will be considered as Minor Misconduct.
  - Every resident must have good behavior with each other and the administration. Violation of the rule can be considered as Minor or Major Misconduct depending on the severity of misbehavior. The decision of Warden/Chief Warden in this regard will be considered as final.
  - Every resident must not keep or use Liquor, Drugs, Weapons and Cigarettes. No one can keep any private servant or pet within hostel. The violation of this rule will be considered as Major Misconduct with expulsion.
  - Every resident must not do any Religious, Regional, Sectorial or Political Activity inside the hostel premises. The violation of this rule will be considered as Major Misconduct with expulsion.
  - Every resident must keep their CNIC and College ID cards with them all the time and must produce them at the time of inspection by any of the members of Hostel Administration. The inspection can be done at any time of the day and will be binding on the student to show their rooms and the cupboards to the inspecting officer. Any hindrance in this process by the student will be considered as Major Misconduct.
  - Every resident must pay the hostel dues in time and any delay in this regard will be liable to cancellation of the allotment and vacation of the room allotted.
  - The hostel dues include the room rent and the electricity charges for lights and fan. The residents must get permission of use of any other electrical appliances in their rooms like AC, Heater, Fridge, Water Dispenser, Microwave oven and Iron. The charges for use of each must be deposited on monthly basis at the rates notified for use of each.
  - Every resident must pay the mess / canteen charges / Any other subscriptions before the 5th of every month. Any delay in payment will be liable to 0.5% per day late payment charges. The non-payment of these liabilities for 3 consecutive months will be considered as Major Misconduct with expulsion.
  - Every resident must be responsible for cleanliness of not only the allotted room but also the hostel premises especially washrooms. Anyone found intentionally damaging the hostel fixtures or spreading the untidiness will be considered as committing Minor Misconduct.
  - Every resident must refrain from cooking in their rooms. The violation of this rule will be considered as Minor Misconduct.
  - Every resident must be responsible for the safety of the belongings. The hostel administration will not be responsible for any loss or damage by theft or otherwise. However, the residents must report such

occurrence to the Caretaker and the administration will help him to find the culprit. If any of the resident is found to be involved in the loss of the other resident or the report of the loss by any resident is proved fake, then both the acts will be considered as Major Misconduct.

18. Every resident must refrain from humiliating junior residents in the name of "FOOLING". The violation of this rule will be considered as Major Misconduct.
19. The old final year students waiting to appear in Supplementary examination must pay the hostel dues for the extra months they want to reside in hostel and must pay the mess etc. charges as per policy.

## DAILY ROUTINE OF RESIDENT STUDENTS

1. The finger sensor operated doors will be installed at the entrance of hostels. No resident can enter or leave the hostel without finger/thumb verification at any time of the day.
2. Any resident student who enters/leave the hostel with other resident student without finger/ thumb verification will be dealt as committing Minor Misconduct.
3. All the residents must exit the hostel with finger/thumb verification for college till 0755 hours on working days i.e., Monday to Friday. Any resident failing to verify his/her exit till that time will be considered as committing Minor Misconduct.
4. In case of any illness or emergency due to which the resident is unable to come to attend the college, the resident must inform the caretaker with reason to mark his/her leave on that day and avoid the fine of Minor Misconduct.
5. All the residents must enter the hostel with finger/thumb verification after attending college till 1530 hours on working days i.e., Monday to Friday. Any resident failing to verify his/her entry till that

time will be considered as committing Minor Misconduct.

6. During the time between 1630 hours till the daily final/night entry time the residents can go to library, cafeteria, book shop, hospital, and sports arena etc.
7. The final night entry time back to hostel is 2100 hours in winter and 2200 hours in summer with finger/thumb verification. After that time no leaving of hostel is allowed till Fajar Prayer time. Any resident failing to register his/her entry back to the hostel till that time will be considered of having committed Major Misconduct.
8. In case a resident commit any of the above-mentioned Minor misconducts twice then the penalty as Major Misconduct will be imposed.

## RULES FOR VISITORS OF RESIDENTS / CAMPUS LEAVING RULES FOR RESIDENTS:

1. Every resident at the time of admission to the hostel must submit a list of visitors along with their CNIC photocopies and photographs who can visit the resident at any time in the hostel. The list must be signed by the parent / guardian of the student. The addition or subtraction in the list must be done by the parent / guardian by personally visiting the campus. No other visitor will be allowed to visit the resident student outside the list. The violation of this rule will be considered as Major Misconduct.
2. Every resident must refrain from bringing the visitors inside their Hostel/Rooms. The visitors are not allowed to stay at night in the hostel premises. The residents must meet their visitors in the college cafeteria. The violation of this rule will be considered as Minor Misconduct.
3. Every resident must ensure that all their visitors should make entry into the visitor register kept with the security staff at hostel entrance. The violation of this rule will be considered as Minor Misconduct.
4. In case of emergency if any other visitor must come

to meet or take the resident student with him the parent / guardian must call the Warden from the number written on the visitor form and intimate the CNIC number and name of the new visitor. Otherwise, no one will be allowed to visit the resident student.

5. Every resident must also submit the list of relatives / visitors with whom the resident can go out of the institution premises (hostel and college) including their names, relationship with the resident, CNIC number and photograph.

6. All the parents / guardians must also submit an affidavit on stamp paper of Rs.100/- with following wording.

“I \_\_\_\_\_ father/guardian of Mr./Ms. \_\_\_\_\_ do ALLOW/NOT ALLOW my son/daughter to go outside the Shahida Islam Medical College premises on their own without any of the relatives / accompanying persons authorized. My son/daughter Mr./Ms. \_\_\_\_\_ is AUTHORIZED/NOT AUTHORIZED by me to sign the hostel leaving form on my behalf after which he/she can go out and even travel alone back to the home. The administration of Shahida Islam Medical College will not be held responsible by me or my family for any untoward incident happening outside the institution premises. I also ALLOW/NOT ALLOW my son/daughter to go outside the Shahida Islam Medical College premises for picnic or excursion during holidays with fellow students. However, he/she will inform the Warden before proceeding and will sign the permission form on my behalf. The administration of Shahida Islam Medical College will not be held responsible by me or my family for any eventuality happening during picnic/excursion”.

7. Any resident wanting to leave the institution premises (hostel and college) must get the

permission from the Warden on the Hostel Leaving card/Form which must clearly show the date and time of leaving, the accompanying person, purpose of leaving and the expected date and time of return. This card/Form would have three leaves.

8. The resident student must submit one leaf of leaving card/form to the caretaker before leaving the institution, so the caretaker is informed regarding the student leaving the hostel.

9. The resident student must submit the second leaf of the leaving card/form at main entrance to the security staff and fill in the entry and exit register kept there with clearly mentioning the date and time of departure from the college premises.

10. The resident student will keep the third leaf of the leaving card/form with him/her.

11. On arrival back to the institute, the resident student will show the third leaf of the Leaving Card/Form to the security staff at the main gate, without which he/she will not be allowed to enter. In the case of loss of the third leaf, the resident student must call the caretaker, who will come to the main gate to identify the student and let him/her in the college. The resident student also must fill in the entry, and exit register kept at the main gate, clearly mentioning the arrival date and time in the college premises.

12. The resident student must return the third leaf of premises leaving card/form to the caretaker upon entering the hostel. The violation of any of these rules from serial No. 7-12 will be considered as Major Misconduct.

13. No resident can remain absent from hostel during nighttime without prior permission from the Warden. The violation of this rule will be considered as Major Misconduct.

14. No female visitor is allowed to enter the boy's hostel and vice versa. The violation of this rule will be considered as Major Misconduct.
